The question is as Curriculum Committee reviews courses and reviewing the content, should the discipline/FSA assigned be changed from Academic Senate to the Curriculum Committee? The discipline = minimum qualifications to teach the course. The discipline/FSA has been historically with the Academic Senate for assignment. This will not impact or have any negative impact from moving it from Academic Senate to the Curriculum Committee. The form attached is to be used if a community college is looking to request a change with ASCCC. Think about it and it will be brought back for further consideration.
- b. Course/Program Sunset Policy Erik Woodbury Currently DA has no course/program sunset policy. Meaning that if a program and/or course has not been earned and/or offered, there is no policy to remove it. Does Curriculum Committee want to develop a policy?
 - Leave it to the departments to determine sunsetting
 - Universities expect a course to be offered if it is on a major
 - Run a list for the deans
 - This impacts guided pathways, and they are working on stating when a course is offered
 - If a course is not being offered, it's a version of false advertising
 - What would be the advantage of having a sunset policy when there might be circumstances of why a course is not being offered like funding and staffing difficulties and not filling (not meeting the minimum number of students)
 - Departments might need some help developing some guidelines
 - If a course is required it should be offered every two years, if it's required for a certificate, it should be offered every year
 - Woodbury will develop a statement with CAT and bring back to CC at the last meeting or first meeting of fall 2023
- c. How to Review Certificate/Degree Programs Should there be a review cycle for programs, like there is for programs? It was proposed there should be one or possibly include it with the annual program review.
- d. Annual Governance Survey Woodbury went through and completed the yearly governance survey with the committee.
- e. Program and Course Review Across the District FYI Woodbury and Thomas Ray have been meeting with their FH counterparts at the request of the Academic and Professional Matters (APM) to discuss a process for new program and new courses development across the district. They have come to an agreement to keep each school informed of new programs. New courses, however, have had some philosophical disagreements. Committee members were supportive of Woodbury's approach and indicated he should keep pursuing more discussion on new courses.
- f. Essential Student Materials/Essential College Facilities Should there be a difference in the list based on the different modalities a course exists in? The committee confirmed that there should be no differentiations made on the COR for the different modalities that

exist for a course. The online/hybrid forms cover the different needs for student materials and college facilities based on the modality.
