NOTICE IS HEREBY GIVEN that at its regular meeting of **Tuesday, May 6 at 6:45 p.m.**, the City of Cupertino City Council will conduct a public hearing – in person at **Community Hall, 10350 Torre Ave, Cupertino, CA 95014** and via teleconference - to consider An Interim Urgency Ordinance of the City of Cupertino, California, Establishing a 45-Day Temporary Moratorium on the Conversion of Multiple-Family Housing to Student Housing Within City Limits During the Pendency of the City’s Review and Adoption of Permanent Regulations of Such Conversions. If you wish to challenge the City Council’s action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written or electronic correspondence delivered to the City of Cupertino City Hall 10300 Torre Avenue, Cupertino, CA 95014 at, or prior to, the meeting.
