Title: Potential Psychological Services Name Change/Rebranding

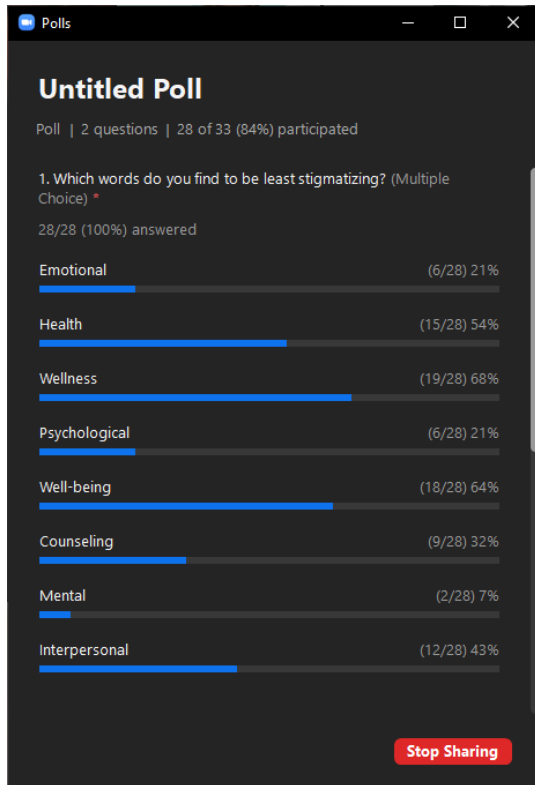

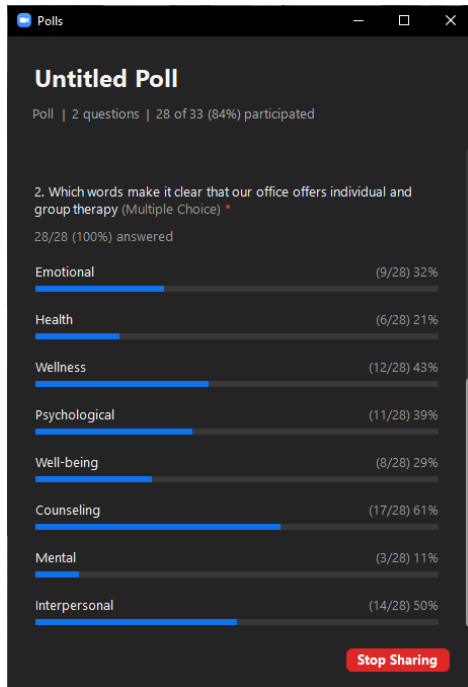
